## CONSTRUCTION NOTICE

### 143<sup>rd</sup> Street West Extension Improvements

Construction of the Ridge Road Water Main Improvements is set to begin the Week of February 12th. The 143rd Street West Extension improvements include 3,200 Ft of new 20 Inch water main along the east side of Ridge Road between 143rd Street/Johnson Road and Kendall County Highway 22. The contractor has already started to prepare work area and began delivering materials to the site. The Ridge Road water main work is expected to last approximately 3 weeks, weather permitting. The work zone will be located outside of the roadway with minimal traffic impacts or delays to traffic on Ridge Road. Additionally, installation of the new sanitary main within the limits of the future 143rd Street extension between Ridge Road and Steiner Road is expected to begin next week. The 143rd Street sanitary sewer work is expected to last approximately 12 weeks, weather permitting.

The 143rd Street West Extension involves constructing a new road between Ridge Road and Steiner Road including improvements along Ridge Road. #### Project Highlights -

- The new 143rd Street roadway will consist of asphalt pavement with curb and gutter between Ridge Road and Steiner Road.
- 143rd Street will consist of single lanes in each direction and a striped center two-way left turn lane.
- Permanent traffic signals with street lighting at the intersection of 143rd Street and Ridge Road.

- Dedicated left turn lanes on each leg of the intersection of 143rd Street and Ridge Road.
- New water main along 143rd Street and Ridge Road.
- New sanitary sewer along 143rd Street.
- A new closed storm sewer system, drainage culvert, and detention basins.
- Roadway reconstruction and widening with aggregate shoulders on Ridge Road approximately 1,000' north and south of the 143rd Street intersection.
- Roadway reconstruction and realignment of Johnson Road for approximately 1,000' west of Ridge Road.
- Ditch regrading, driveway apron replacements, and aggregate shoulders along Johnson Road and Ridge Road.
- Pavement marking and landscaping improvements throughout.

**Contractor Information** – The General Contractor for the project is Austin Tyler Construction out of Elwood, Illinois. They will be self-performing the underground sewer and water utility improvement work as well as roadway construction.

#### **General Schedule -**

- **Winter 2024**
  - Tree clearing, installation of sanitary sewer along 143rd St., and water main along Ridge Rd.
- **Spring 2024**
  - Install the drainage culverts for 143rd St., Ridge Rd., and Johnson Rd.
  - Roadway widening improvements along Ridge Rd. and Johnson Rd.
  - Earthwork for the new 143rd St. roadway and detention ponds.
- **Summer 2024**
  - Continued earthwork for the 143<sup>rd</sup> St. roadway improvements.
  - Complete water main along 143rd St.
  - Installation of storm sewer along 143rd St.
  - Construction of the new 143rd St. curb and gutter and asphalt pavement improvements.
- **Fall 2024**
  - Complete construction of all roadway improvements including final lift of asphalt, shoulder stone, and ditch grading
  - Complete pavement markings, signage, and landscape restoration.
  - Installation of the new permanent traffic signal at 143<sup>rd</sup> St. and Ridge Rd.
  - Open the new 143<sup>rd</sup> St. west extension!

**Daily Work Hours** – Daily work hours are from 7:00 am to 7:00 pm, Monday thru Friday; and 7:00 am to 5:30 pm, on Saturdays.

**Notifications** – Notifications will generally be sent out on a regular basis, to keep property owners informed of the current progress and activity of the overall project. In addition, detailed notifications will be delivered to property owners to inform them of temporary loss of driveway access and other critical construction activities. The project website will also be updated on a regular basis to notify the public of progress made, upcoming construction activities, and updates to the overall project schedule.
